### 1. Apologies for Absence

## 2. Declaration of Interest for items on the agenda

## 4. To note complaint and appeal correspondence

The complaint and appeal correspondence was **noted**. The full schedule of legislation relating to the complaint was noted, as the complainant had only quoted a partial extract. It was noted that the Council as a whole had agreed the Stage 1 response.

# 5. To suspend Standing Orders and receive verbal representation from the complainant

## 11. To consider the independent report and earlier representations, and reach a decision regarding complaint

The Council considered all available information and the following decision was made:

Complaint 1: That the decision to spend up to £700 on a lorry load of Type 1 for the Track at The Common was not specified on the agenda

This complaint is not upheld because the agenda does state that the Track would be discussed. The Council is happy to take forward the suggestions from the Independent Report and the Monitoring Officer that future agendas will not have Matters Arising; and that more detailed agenda items will be given, with costings / reports being brought forward where relevant. The March 2025 meeting would ratify the decision to purchase the Type 1, to regularise the situation.

Complaint 2: That the spending of funds towards the Village Hall grounds maintenance and car park was not specified on the agenda

This complaint is not upheld because no decision was made on the stated expenditure, this decision was deferred to the January 2025 meeting.
