- 4.1 To receive reports from County and Borough Councillors and Police Report. A Thompson since the first lockdown the parish has collected food for food banks and received donations, continue to raise money and donating food. An additional grant for parish village halls have been received to support them in relation to the impact of Covid. On the 9th of December 2022 the full GYBC meeting set the local plan, there was no allocation for large scale development in the parish. There is a 5-year plan for development now in place. Filby Neighbourhood Development Plan will be going to referendum on the 24th of February 2022. For the Queens Jubilee A Thompson will be purchasing 5 trees for Fleggburgh to plant to mark the occasion. Lastly grants for new playground equipment are currently being exploring.
